How to use this list

1. Locate your Eligible Energy Measure (EEM) on the table. To qualify for financing, EEMs must be Title 20 or Title 24 compliant.
2. Check the Program Requirements on the table (e.g., ENERGY STAR) to confirm that your measure is eligible
3. EEMs must be installed by a [GoGreen Home contractor](#). Measures that are eligible for self-install have a checkmark in the SI column and do not require a GoGreen Home contractor.
4. EEMs with a checkmark in the **IOU** (Investor Owned Utility) column are available to customers who receive electric service from an IOU (PG&E, SoCalGas, SCE or SDG&E).¹
5. EEMs with a checkmark in the **POU** (Publicly Owned Utility) **w/ IOU Gas** column are available to customers who receive electric service from a POU (SMUD, LADWP, etc.) and gas service from an IOU.
6. EEMs with a checkmark in the **POU w/out IOU Gas** column are available for those with POU electric service and no gas IOU service.

¹ Customers who receive electricity from an IOU but gas from a source other than PG&E, SoCalGas or SDG&E (e.g., propane provider, Southwest Gas, or a publicly owned utility such as City of Long Beach) may apply no more than 30% of the loan toward gas designated measures.
